



## **Promotional terms and conditions Agrolux/Gavita win promotion at HortiContact 2024**

### **General:**

1.1 These promotional terms and conditions (hereinafter: "the Promotional Terms and Conditions") apply to the promotional promotion organized by Gavita International B.V.
